## RE; A PROPOSAL OFFERED FOR DISCUSSION BY THE NATIONAL CABINET

Thank-you for responding to my letter. I would like to take the opportunity to outline, in more detail, an offer I made in a previous letter and I request that you table this offer before the National Cabinet for discussion.

The Worqour currency was only ever intended to be used as an international bridging currency. As luck would have it a second configuration of the payment system can, in an emergency, introduce limitless amounts of FREE funds into an economy. (See website <worqour.info> Section 06)

Right now we are in the throws of a disastrous double emergency. Both the health and economic welfare of the Australian nation is under threat and it goes without saying, I will do anything I can to help.

I believe Australian Patent No. 2014280970, which gives me protection over a device I have invented, also grants me legal title to the Worqour currency used by that patented device.

Because there is a desperate need for cash during this emergency what I'm offering to do is sell, 'Worqours' units of time with a monetary value, at a significant discount, to the various Australian governments.

I'm not sure there are legal grounds to stop me offering my deal to the Australian governments. Any attempt to stop me could cause a massive legal kerfuffle because.......

The business of selling units of time, in various forms, is already a widely accepted practiced throughout the economy.

Any challenge to the legitimacy of my proposals might bring into question;

- The rights of hotels/motels to sell, units of time with a monetary value called 'night (accommodation)' to the travelling public.
- 2) A city council's right to sell 'time in parking spaces'. In this sale the time charges are measured and collected by parking meters.
- Internet service providers sell time. Their basic service provider deal generally involves a month's access to the Internet.
- 4) The greatest and most obvious selling of time involves workers who sell their time, most often by the hour, to employers. These employers base their purchase price on what special skills the workers are using during that hour. The government is even involved in regulating the minimum hourly rate amount, in national currency, this time can be sold for.

Selling the Worqour a unit of time that I legally own? It may be a bit novel and unusual but I don't think I'm proposing anything unlawful.

What I am offering the various Australian governments is the opportunity to purchase Worqour currency at a discount.

The minimum hourly rate (mHR) \$19.49 is the current official rate set by the Fair Work Commission. Using that Aust. (mHR) in the patented primary cross-border currency transfer equation: one Worqour can currently be exchanged for 19.49 Australian dollars. In the primary currency transfer configuration the \$19.49 is fixed and can only be altered by Australia's Fair Work Commission.

The secondary configuration that allows for the introduction of cash into the economy needs the government's authorization. This emergency Worqour cash injection is a one-way transaction between Worqour International and the government and for this reason the currency involved is subject to negotiation.

What I'm offering the various Australian governments is 1 Worqour at 1.949 Australian dollars. That's 90% less than the Worqour's standard conversion value and the equivalent of saying, 'Give me a \$1 coin and I'll give you a ten dollar note in exchange".

This arrangement would require the government to pre-pay 10% of the total Worqour value it wants to purchase and afterwards deposit the full Worqour value into an authorized account

OR

Alternatively, the government can agree to deposit the full currency value sourced from discounted Worqour certificates into the authorized account and reimburse the 10% in Australian dollars.

One dollar exchanged for a ten dollar note that's nine dollars FREE money.

What I want to convey to the Australian Federal, State and Territories governments is this...

'In purchasing the discounted Worqour currency certificates governments don't need to worry about how much they're spending. They just need to concentrate their focus on the nations health and ways to get financial support to everyone, every business, whoever needs financial support.

Also, this offer will not cause a double-up of earnings within the economy because the Worqour certificate cash is temporary and only substituting for the human workforce and businesses that are in hibernation and not generating any cash flows. Rents, business overheads, whatever, can also be included in the Worqour generated cash-flow substitution.

The emergency Worqour sourced funds I'm offering to supply will not increase the national debt because they don't have to be repaid and governments can spend without restrictions because the source of their emergency spending is unlimited.

This arrangement could also get the Australian Government out of at least one bind. The government could authorize Virgin Australia to negotiate and purchase the Worqour currency it needs to finance it's own financial shortcomings. Remember, the Worqour is a bridging currency that operates outside between national economies and emergency Worqour currency injections cannot be introduced into the economy without the government's knowledge and authorization.

Whether PM Morrison and the National Cabinet decides to follow the well-worn, established, bond issuing, debt increasing path, or, embrace the 'new currency debt-free life-line' we'll have to wait and see.
